**SUMMARY:**

As a professional motorcoach operator, the ideal candidate will have a strong commitment to safety, excellent driving skills, and the ability to interact positively with customers and field personnel to ensure the safe and timely transportation of our customers. This role is based in our Allegheny Crew Change division and will consist of transporting customers on scheduled routes between Jamestown, NY and Buffalo, NY and Jamestown, NY and Olean, NY. Opportunities for full time, part time, split shift and non-split shift motorcoach operators. Drivers will return **home daily** with **no overnight travel** and be responsible for compliance with all DOT, FMCSA, pre-trip and post-trip procedures and guidelines.

**CORE RESPONSIBILITIES:**

- Provides safe and efficient transportation of passengers via motorcoach along designated routes in accordance with all local, state, and federal regulations.
- Conducts comprehensive pre-trip and post-trip vehicle inspections and reports any mechanical issues to ensure safe operating conditions.
- Acts as the front-line point of contact to ensure the highest quality of service is delivered to our customers in a friendly, courteous, and professional manner.
- Assists passengers with boarding as well as collects tickets and fares.
- Communicates with field personnel to report any delays, incidents, or concerns.
- Promotes safety awareness and follows safety procedures to avoid incidents and accidents.
- Completes all required documentation and maintains driver logs according to company regulations.
